

Explore Denali Hiking

Acknowledgement of Risk Form

- **Please read this document carefully and thoroughly** •

The activity of engaging in a hike is a personal choice and is done so with an understanding that certain risks are inherent. The guest or participant of a ***Explore Denali*** excursion acknowledges that he or she possesses the ability to walk and is aware that the surfaces may or may not be improved and could include travel over uneven terrain characterized by gravel, river rock, boulders of varying size, downed foliage, exposed or hidden plant roots or tree limbs, all of which could be slippery in both wet and dry conditions. ***Explore Denali*** personnel reserves the right to request that any prospective participant of a ***Explore Denali*** activity demonstrate their ability to walk, unassisted, before allowing that individual to participate.. The following conditions and safety rules are to be followed at all times while participating in a ***Explore Denali*** excursion:

1. Any participant in a ***Explore Denali*** activity will be required to adhere to ***Explore Denali*** requirements for proper footwear. Footwear represents a vital part of our commitment to the guest's safety. We will reserve the right to refuse participation in any ***Explore Denali*** activity based on the footwear.
2. No passenger will be allowed to participate in a ***Explore Denali*** hike without reading and signing the ***Explore Denali*** Acknowledgement of Risk form.
3. All participants on a ***Explore Denali*** hike will adhere to the directions of the ***Explore Denali*** hiking guide, and will stay on trail when the guide requests it.
4. ***Explore Denali*** requires that all participants acknowledge that they are in good enough physical fitness to participate in the activity outlined above.
5. ***Explore Denali*** requires that the participant has verified their ability to participate in this activity. If the participant has prior medical concerns that might interfere with their ability to engage in hiking, they declare that a physician has declared them to be physically and psychologically fit to participate in the experience.
6. ***Explore Denali*** requires that the participant acknowledge that they are fully capable of participating in this activity without causing harm to themselves or others.

THE UNDERSIGNED PARTICIPANT AGREES AND UNDERSTANDS THAT HIKING IN A WILDERNESS SETTING INVOLVES RISK OF SERIOUS PHYSICAL INJURY INCLUDING POTENTIAL DEATH. WITHOUT LIMITATION, INJURY CAN BE CAUSED BY FALLS, TRIPS, SLIPS, NATURAL DEBRIS, ROOTED, FIXED OR MOVING. INJURY MAY ALSO RESULT FROM CERTAIN, UNFORSEEN AND UNAVOIDABLE CONTACT WITH ANIMALS, PLANTS OR ROCKS. HIKING SHOULD BE UNDERTAKEN ONLY BY PERSONS IN GOOD PHYSICAL CONDITION AND HEALTH THAT ARE ABLE TO TOLERATE MODERATE TO STRENUOUS PHYSICAL EXERCISE. THE UNDERSIGNED PARTICIPANT ASSUMES ALL RISK OF PERSONAL INJURY, INCLUDING DEATH, DAMAGE OR LOSS OF PROPERTY RESULTING FROM THE ACTIVITY DESCRIBED HEREIN. THE UNDERSIGNED RENTER AND/OR PARENT OR GUARDIAN EXPRESSLY RELEASES AND WAIVES ANY CLAIMS AGAINST ARAMARK LEISURE SERVICES, INC., AND ITS AFFILIATES, AND THEIR RESPECTIVE OFFICERS, DIRECTORS AND EMPLOYEES RESULTING FROM THEIR PARTICIPATION IN THIS ACTIVITY .
